

Proposed changes to NDNA bylaws: September, 2015

Article 3.1

Proposed wording: Notice of any such meeting, along with the agenda, shall be published in a mailer, by a flyer, or email or other electronic means at least seven (7) days prior to the meeting.

Former wording: Notice of any such meeting, along with the agenda, shall be published in a mailer or by a flyer at least seven (7) days prior to the meeting.

Article 4.1

Proposed wording: The elective officers of the Alliance shall be President; Vice Presidents of (1) Beautification/Code Enforcement, (2) Membership, (3) Planning/Zoning, (4) Public Relations-Website, (5) Safety/Traffic and Transportation (6) Secretary, and (7) Treasurer.

Former wording: The elective officers of the Alliance shall be President; Vice Presidents of (1) Beautification/Code Enforcement, (2) Membership, (3) Planning/Zoning, (4) Public Relations-Website, (5) Safety/Traffic and Transportation chair(6) Recording Secretary, and (7) Corresponding Secretary & Newsletter Editor, and (8) Treasurer.

Article 4.5

Proposed wording: Prior to the month of October each year, a nominating committee shall be appointed by the President for the purpose of selecting nominees for each eligible office for the next operation term.

Former wording: Prior to the month of October each year, a nominating committee shall be appointed by the President for the purpose of selecting nominees for each eligible office for the next operation year.

Article 5.2 (A)

Proposed wording: The President will be a regular member of the board an ex officio member of all permanent committees.

Former wording: The President will be a regular member of the board an ex office member of all permanent committees.

#### Article 5.2 (C)

Proposed wording: Membership will assist the Treasurer in maintaining a complete roster with information regarding number of homes and organization's assessment for purposes of dues.

Membership will assist with information necessary for dispersing information pertinent to the Alliance and member associations.

Former wording: Membership will assist the Treasurer in maintaining a complete roster with information regarding number of homes, and organization's assessment for purposes of dues. Membership will assist the Corresponding Secretary and Newsletter with information necessary for dispersing information pertinent to the Alliance and member associations.

#### Article 5.2 (H)

Proposed change: Eliminate the section and indicate (I) is now (H)

Former wording: The Corresponding Secretary and Newsletter shall assist the President in preparing correspondence and developing a newsletter.

#### Article 6.1

Proposed wording: The board of Directors shall consist of the Officers identified in 4.1 plus all Standing Committee heads.

Former wording: The board of Directors shall consist of the Officers identified in 4.1 plus and all Standing Committee heads.

#### Article 9.1

The bylaws may be amended, repealed, or modified in whole or part at any regular meeting of the Alliance upon affirmative vote by two thirds (2/3) of the members present, provided, however, that notice of any proposed amendment shall be posted on NDNA's website and sent electronically to each member at least seven (7) days prior to the meeting at which a vote is to be called.

Former wording: The bylaws may be amended, repealed, or modified in whole or part at any regular meeting of the Alliance upon affirmative vote by two thirds (2/3) of the members present, provided, however, that written notice of any proposed amendment shall be given to each member at least seven (7) days prior to the meeting at which a vote is to be called.
